2. ANNUAL MEMBERSHIP CANCELLATION

I agree that all annual memberships are non-transferable, and membership may be terminated, and pro-rata refund given only if the member moves more than 25 miles from the club. The membership will be refunded pro-rata 30 days from the receipt of a utility bill, lease or mortgage agreement from the new residence. Membership accounts cancelled prior to a 6-month term will be charged the month-to-month enrollment fee shown upon sign-up.

ADDITIONAL RIGHT OF CANCELLATION: If upon a medical doctor's order you cannot physically receive services of this facility because of significant physical disability in excess of six months. If you become deceased, your estate shall be relieved of any further obligation for payment under the contract not then due or owing.

All monies paid pursuant to contract cancelled for the reasons contained in this subdivision shall be refunded within fifteen business days of respect of such notice of cancellation; provided however that the seller may retain the expense incurred and the portion of the price representing the services which the buyer has consumed or wishes to retain after cancellation of contract.

MONTH-TO-MONTH MEMBERSHIP CANCELLATION

Members paying monthly dues will owe any payments due in the 30 days after providing written request for cancellation.

ADDITIONAL CONSUMER RIGHT TO CANCELLATION. You may cancel this contract without further obligation within 3 days from this date.

Notice of cancellation shall be given in writing subscribed by the buyer and mailed by registered or certified United States mail to the seller at the address specified in such form. Such notice shall be accompanied by any membership cards, locker keys and any other documents or evidence of membership previously delivered to the buyer.

By execution below, member acknowledges that The Club of Riverdale will not reduce, refund any portion, or suspend the membership fee during the time when the facilities, in whole or in part, are not available for use (Holidays/Maintenance/Emergency), or upon the disability of the undersigned, or the absence from the use of the facility by the undersigned. A member's cancellation of the membership shall not relieve that member of his obligation to make payment of membership fees for the remainder of the year, which will continue to be billed as provided on the other side of this application.
